Judges Counselling Program

The judicial role is one that is marked by high expectations. Making the right decision, knowing that it will be subject to the scrutiny of the public and one's peers, creates stresses that are unique to the role of a judge.

Even those who excel in the performance of judicial duties quietly admit that it sometimes comes at a great personal expense to judges and those closest to them. The need to maintain an image of being able to meet the heavy responsibility of judicial office makes it difficult for many of us to ask for help.

The Judges Counselling Program (JCP) is designed to respond to the unique stresses that judges and their families endure.

JCP is a voluntary, confidential, short-term counselling and advisory service that connects you and your eligible family members to a network of dedicated professionals who are available to give you assistance 24 hours a day seven days a week.

The professional service is provided by Shepell.fgi, one of Canada's largest and most respected behavioural health service providers.

Shepell-fgi's network is made up of experienced counsellors, psychologists, social workers and specialists. Their experts are ready to assist you with your personal concerns anytime you require assistance.

JCP provides professional counselling for a wide range of issues, which may impact judges and their families:

- Stress and burnout
- Depression and anxiety
- Relationships
- Bereavement
- Life changes
- Substance abuse and addictions
- Coping with illness
- Crisis counseling

Is the service really confidential?

Confidentiality is the cornerstone of the ICP. Information is never shared with anyone outside of Shepell fgi without an individual's informed, voluntary and written consent, with the exceptions listed below.* Unless you tell them, no one will even know that you have contacted the JCP.

*Understandably, certain exceptions apply when information must be provided to others, whether or not consent is given - such as when a person appears to pose a threat of serious injury to themselves or others. Also, Shepell fgi's professionals are legally required to report suspicion of child abuse and to disclose information required by law (e.g. a court order).
